

## Employer NCRC Requirements 9/21/17

---

In order to NCRC test for any employer, applicant must bring paid receipt or referral form, (must bring printed paid receipt from Gaston College Business Office –no copies), valid government issued photo ID, and social security card or tax ID number (in lieu of SS card – may use previous year’s tax forms or W2 that have not been altered).

Reading for Information = \$ 20.00

Applied Mathematics = \$ 20.00

Locating Information = \$ 20.00

Applied Technology = \$ 20.00

Workplace Observation = \$20.00

Business Writing = \$20.00

Fit = \$25.00

Talent = \$25.00

**Affinia (WIX)** – Requires any passing Level in Reading for Information, Applied Mathematics, and Locating Information – **Affinia (WIX)** pays for its employees to test – must bring a referral from **WIX or a paid receipt**

**Charlotte Mecklenburg Schools** - requires a Level 4 in Reading for Information and Applied Mathematics,– **Charlotte Mecklenburg Schools** does not pay for testing - must bring paid receipt – **Please check with Charlotte Mecklenburg Schools before testing as requirements may change**

**Chemtura** – requires a minimum of Level 5 in Reading for Information, Level 3 in Applied Mathematics, Level 4 in Locating Information (Higher Levels Required for Chemical Operators) **Chemtura** pays for it permanent employees with a referral – temporary employees and applicants must bring paid receipt

**City of Rocky Mount Fire Department** requires Level 5 in Reading for Information, Level 4 in Applied Mathematics and Level 4 in Locating Information – **City of Rocky Mount Fire Department** does not pay for testing – must bring paid receipt

## Employer NCRC Requirements 9/21/17

**CMC Rebar** – requires Level 4 in Reading for Information, Applied Mathematics, Locating Information. Must either bring a referral from **CMC Rebar** or must bring paid receipt

**Curtiss Wright** – prefers a Level 4 in Reading for information, Applied Mathematics, and Locating Information – **Curtiss Wright** does not pay for testing – must bring paid receipt

**Daimler Freightliner – Gastonia** – Requires Silver CRC and proof of CRC – **Must be taken in English - Daimler Freightliner** does not pay for testing – must bring paid receipt

**Dole** – Requires Level 3 in Reading for Information, Applied Mathematics, Locating Information. – **Dole** pays for current employees, but must bring referral from **Dole** or a paid receipt

**Firestone Textiles** – Requires CRC - any Level — **Must be taken in English - Firestone** pays for employees- must bring referral from Firestone (Firestone may email) or a paid receipt

**Gaston County Schools** - requires a Level 4 in Reading for Information and Applied Mathematics,– **Gaston County Schools** does not pay for testing - must bring paid receipt – **Please check with Gaston County Schools before testing as requirements may change**

**Gastonia Fire Department** requires: Level 4 in Reading for Information, Applied Mathematics and Locating Information – **Gastonia Fire Department** does not pay for testing -must bring paid receipt

**Gastonia Sheet Metal** prefers any level CRC – Gastonia Sheet Metal does not pay for testing – must bring paid receipt

**GKN** – requires CRC – check with GKN to verify the required level – GKN does not pay for testing – must bring a paid receipt

**Lincoln County Schools** – requires a Level 4 in Reading for Information and Applied Mathematics – **Lincoln County Schools** does not pay for testing – must bring paid receipt – **Please check with Lincoln County Schools before testing as requirements may change**

## Employer NCRC Requirements 9/21/17

**Kaco USA** – Requires Level 3 in Reading for Information, Applied Mathematics, and Locating Information – **MUST BE TAKEN IN ENGLISH** – **KACO USA** does not pay for testing – must bring paid receipt

**Mooreville Fire Dept.** – requires: Level 4 in Reading for Information, Applied Mathematics and Locating Information – **Mooreville Fire Department** does not pay for testing -must bring paid receipt

**Owens Corning** – requires Level 5 in Reading for Information, Level 5 in Applied Mathematics, Level 4 in Locating Information - **Owens Corning** emails applicants specific test date and time - ***Owens Corning pays for 1st time testing only*** – ***All retests must have a paid receipt***

**PPG in Shelby** – Requires a Level 4 in Reading for Information, Applied Mathematics, and Locating Information – **PPG in Shelby** does not pay for testing - must bring paid receipt

**Schaeffler Group** – Fort Mill, SC – Requires Level 4 in Reading for Information, Applied Mathematics, Locating Information– **Schaeffler Group** does not pay for any assessments - must bring paid receipt

**Siemens** – requires a Level 4 in Reading for Information, Applied Mathematics, Locating Information, and any passing Level in Applied Technology – **Siemens** does not pay for testing at Gaston College - must bring paid receipt

**Statesville Fire Dept.** - prefers Level 4 in Reading for Information, Applied Mathematics and Locating Information– **Statesville Fire Department** does not pay for testing -must bring paid receipt
