Getting Started in the Gaston College Health & Fitness Science Program

Students applying to the Gaston College Health & Fitness Science program (HFS) MUST complete the following requirements for GENERAL ADMISSION to the college:

- Submit an Application online at www.cfnc.org/gastonapp or send application by mail to: Gaston College Admissions Office 201 Highway 321 South Dallas, NC 28034
- Financial Aid: After the application for admission has been submitted, the student should complete a Free Application for Federal Student Aid (FAFSA). The student who wishes to apply for financial assistance must file a Free Application for Federal Student Aid (FAFSA). The student should complete the FAFSA form on the Internet at www.fafsa.gov using Gaston College school code #002973. It takes 4 6 weeks to process a complete file. Therefore, students should submit all financial aid forms several weeks prior to their enrollment date. In addition, the student should submit other documentation if requested by our office. Additional documentation includes the College Financial Aid Application, the Verification Form, and other financial information. Students interested in scholarships, and/or work-study should submit a separate Gaston College Foundation Scholarship Application and/or Work-Study Application.
- Submit to the Admissions Office an official high school transcript (sealed and unopened).
- Submit to the Admissions Office an **official college transcript(s)** (sealed and unopened) from all colleges and/or universities attended to earn transferrable credits.
- Schedule to take the **Placement Test(s)** needed for the program. For more information on exemptions or to schedule a test call 704.922.6213/6214/6216/6219 or visit http://www.gaston. edu/admissions/info.php Remember, prior to scheduling the Compass Placement Test, <u>you must have already submitted an admissions application to Gaston College</u>.
- Complete the Gaston College new student orientation. This orientation can be completed online using the following link: http://www.gastoncollegeonline.com/userlogin.inc.php.
- Complete a Health & Fitness Science Program Application and submit to the Coordinator of the HFS program.
- Schedule interview with the Coordinator of the Health and Fitness Science program.

Students who have been accepted to the Gaston College Health and Fitness Science Program **MUST** complete the following requirements before starting the first semester:

- A Letter of Acceptance will be mailed from the Health & Fitness Science program for each student after the application is received.
- Attend HFS Campus Orientation.
- Contact Coordinator or Instructor for Course Advising.
- Complete and return **Medical Examination Forms** to Coordinator of the Health & Fitness Science program.

- Complete **TB Skin Test** and provide a copy of results to the Coordinator of the Health & Fitness Science program.
- Complete **Compliance Section** of your packet: <u>Criminal background check, and drug</u> <u>screening</u>.
 - Criminal background Check using www.CertifiedBackground.com
 - Drug Screening (this will be completed during the second year of the program)
- Send or bring your **completed Compliance Forms** immediately to the Gaston College compliance specialist at the address below. Bring it or mail it immediately upon receipt to the Gaston College Compliance Specialist.

PROGRAM INFORMATION

Curriculum Description

The Health and Fitness Science curriculum prepares multi-skilled fitness professionals qualified to perform various skills in the health and fitness industry.

Course work includes instruction in exercise science, fitness and exercise testing, fitness management, prevention and care of injuries, group exercise, personal training, exercise programming, working with special populations, and ethical/legal issues associated with the fitness industry. Students will select one of two concentrations in the program: transfer preparation or small business management.

Graduates of the Health and Fitness Science program will be required to sit for the American College of Sports Medicine Certified Personal Trainer Exam before graduation. Graduates may also be eligible to sit for a variety of other examinations that pertain to the health and fitness industry. Employment opportunities include YMCA's, fitness studios, parks and recreation departments, hospitals, sports performance facilities, and other health and fitness areas.

ADMISSION REQUIREMENTS

Students applying for admission to the Gaston College Health and Fitness Science program **MUST** meet the following requirements for **GENERAL ADMISSION** to the college:

- 1. Complete and submit application online or pick up application at the Admissions Office on the main, campus, Dallas, Campus, 2nd floor Myers Center.
- 2. Request that your high school mail an official high school transcript to Gaston College Office of Admissions. The documentation listed below can be submitted in the place of traditional high school transcript: Official Adult High School transcript, official transcript from an accredited correspondence school/institution, official transcript from Home School, official transcript from a regionally accredited college or university reflecting an Associate Degree or higher.
- 3. Request that all colleges/universities previously attended submit official transcripts to above address. Transcripts must be in the registrar's office by December, 31 in order for courses to receive points for admission in the Health and Fitness Science Program.
- 4. Take placement test as determined by the Gaston College Admissions Office. If you have taken the Accuplacer (CPT), COMPASS, and/or ASSET within the past five years at another college or university, please request that the scores be submitted to the Admissions Office.
- 5. Complete new student orientation. http://www.gastoncollegeonline.com/userlogin.inc.php
- 6. Meet with a counselor or academic advisor for selection of courses, registration and specific information about the Health and Fitness Science Program.
- 7. International students must meet all admission requirements listed under General Admission Requirements. Proof of English proficiency is required. This may be established by making a minimum score of 540 (207 on the computer) on the Test of English as a Foreign Language (TOEFL).
- 8. Complete an application for the Associate Degree Health and Fitness Science Program in addition to the general application to Gaston College.

ADDITIONAL REQUIREMENTS

To be eligible to submit an application to the Health and Fitness Science Program:

- 1. Recent High School Graduate- Must have an overall grade point average of 2.8 or higher in high school courses or ACT score of 16 or higher or SAT score of 900 or higher or
- 2. Current college student- Must have an overall grade point average of 2.0 or better in required college courses or ACT score of 16 or higher or SAT score of 900 or higher
- 3. Prior to entering the Health and Fitness Science Program, you should complete coursework up through, or place out of developmental math 040 and DREQ 098.

- 4. Must have grades of "C" or better in all related courses.
- 5. Must have completed the required Biology courses within 10 years from the date of application to the program.
- 6. Criminal Background Checks and Annual Drug Screening. In order to comply with current Student Facility Affiliation Agreements students admitted into the Health and Fitness Science Program will be required to complete successful Criminal Background checks and Drug Screens according to Gaston College procedures before being placed in a co-op facility. The facility reserves the right to deny the student access to the facility. If the student is denied access, the student will not be allowed to continue in the program. Completion of co-op work experiences is required for the satisfactory completion of the program. More information will be provided upon conditional acceptance into the program.
- 7. A completed North Carolina Community College Student Medical Form documenting satisfactory emotional and physical health is required before entrance into the program by date to be announced by the Health and Fitness Science Coordinator.
- 8. Additional Criteria: Students may be required to submit documentation of additional nonacademic criteria such as, but not limited to, Criminal Background Checks and/or fingerprints. More information will be available upon conditional acceptance to the program.
- 9. Applicants should be aware that travel in "out-of-service" areas may be required for Work-Based Learning experiences.

All above information must be provided and approved prior to enrollment in the program.

The <u>following criteria</u> will be utilized by the Admissions Committee in the selection process of recommending applicants for admission to the Health and Fitness Science Program:

While the ACT Score and the completion of all developmental level courses is the only required admission criterion, ADDITONAL ADMISSION POINTS can be earned from the following categories

- a. College degree/diploma
- b. College level Anatomy & Physiology course
- c. College level English course
- d. College level Math course
- e. College level Physical Education/Health courses
- f. CPR Certification (current)
- g. College level Psychology course
- h. Accredited Fitness Certification (current)
- i. Previous fitness experience
- j. Interview conducted by the Admissions Committee

HEALTH REQUIREMENTS

1. Physical health is defined as being free of disabling or contagious disease, being able to perform fine and gross motor skills, and being able to perform normal weight-bearing activities.

A completed health form documenting satisfactory emotional and physical health is required before entrance into the program. Date required will be announced by the Health and Fitness Science Coordinator.



2. Emotional health is defined as reacting appropriately to stressful situations, withstanding everyday environmental stresses with little difficulty, using healthy coping mechanisms, and understanding one's own ability to cope with stressful situations.

Assessment of emotional health of applicants is made through the use of physical examinations, references, letters from psychiatrists or therapists if intensive therapy is in progress or has occurred, and psychological evaluations, if necessary.

Guidelines for Completing Immunization Record

IMPORTANT – The immunization requirements must be met; or according to NC law, you will be withdrawn from classes without credit.

Acceptable Records of Your Immunizations May be Obtained from Any of the Following: (Be certain that your name date of birth, and ID Number appear on each sheet and that all forms are mailed together. The records must be in black ink and the dates of vaccine administration must include the month, day, and year. Keep a copy for your records.)

- High School Records These may contain some, but not all of your immunization information. Contact Student Services for help if needed. Your immunization records do not transfer automatically. You must request a copy.
- Personal Shot Records Must be verified by a doctor's stamp or signature or by a clinic or health department stamp.
- Local Health Department
- Military Records or WHO (World Health Organization Documents)
- Previous College or University Your immunization records do not transfer automatically. You must request a copy.

IMMUNIZATION REQUIREMENTS

ALL STUDENTS must have the results of a TUBERCULIN SKIN TEST done WITHIN ONE YEAR PRIOR TO ENROLLMENT in the Gaston College Health and Fitness Science program.

An **UP-TO-DATE TUBERCULIN TEST** is required for **EACH ADDITIONAL YEAR** of program enrollment.

- a. History of varicella (chicken pox) OR Varicella Titer. *If results do not indicate immunity* (ask the HCP) 2 immunizations are required. Statement of having the disease is NO LONGER ACCEPTED.
- b. History of physician diagnosed measles is acceptable.
- c. ONLY laboratory proof of immunity to rubella is acceptable (Rubella titer). Rubella is not required if 50 years or older.
- d. The Hepatitis B Vaccine (recommended immunization) must be completed (series of three [3] injections) by the end of the spring semester, Freshman Year.

Note: Those students who do not pursue immunization for Hepatitis B will required to sign a waiver releasing Gaston College and the Health and Fitness Science Program of any responsibility for the possibility of their contracting Hepatitis B.
